UGC has recently notified *UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015* in the Official Gazette on 2<sup>nd</sup> May, 2016 which, being statutory in nature, are binding on Universities and Colleges. You are requested to send the Annual Return on cases of sexual harassment as per proforma (available on UGC website) for the period from 1<sup>st</sup> April, 2015 to 31<sup>st</sup> March, 2016 and also send details of constitution of ICC to the UGC on email i.e. [ugc.iccgs@gmail.com](mailto:ugc.iccgs@gmail.com) latest by 31<sup>st</sup> August, 2016 to enable UGC to compile and furnish the information to the Government of India. This may also be brought to the notice of the affiliated Colleges of your esteemed University for compliance, who should send the report through their affiliating University.
